NOTICE

Sub:- Written Examination of Customs Brokers Licensing Regulations 2013 to be held on 28.01.2015 - reg.

All the candidates, who have applied for written examination under Regulation 6 of the Customs Brokers Licensing Regulation' 2013 with reference to the Public Notice No. 16/2014 dated 27.10.2014 issued by this Commissionerate, are hereby informed that the said written examination will be held on **28.01.2015 between 10.00 hrs to 13.00 hrs.** at '**Conference Hall, 1st floor, New Customs House Building, Near Balaji Temple, Kandla, Kutch**'. The Roll No. to the intending provisionally / finally eligible candidates to appear in the said examination is allotted as per Annexure-I (enclosed).

The intending candidates who have been allotted the Roll Nos. are hereby instructed that:

- (i) They should remain present at 09.30 hours in the examination hall on the scheduled date and venue.
- (ii) They should bring original CHA card/photo identity card etc.
- (iii) No Books / Notes / any other material / Cell phone / i-pad etc. shall be allowed to be taken inside the examination hall. Any attempt to indulge in the malpractice during the examination shall automatically disqualify the candidature.
- (iv) Candidates found taking resources to any unfair means in the examination shall render themselves liable for expulsion at the discretion of the invigilator. No candidate shall intentionally or unintentionally extend or receive from any other candidate, any unfair assistance in the examination hall.
- (v) If, the graduate and post-graduate degree certificates submitted by them for Regulation 6 of CBLR' 2013 examination found fake or unauthorized university degree, etc., formal police complaint will be filed for further course of action and their candidature will be rejected.
- (vi) Their candidature is provisional and if at any stage it is found that they are not eligible to appear in the said examination [due to non-satisfaction of terms and conditions as prescribed under CBLR' 2013] and non-possession of qualification as prescribed under CBLR' 2013, their candidature will be liable for cancellation.
- (vii) Nothing is written either on the front or back of the first page of answer booklet other than the Roll no of the candidate given by the concerned Commissionerate, place of the examination, date of examination. No candidate should write roll no or put initial or marks etc. inside the answer sheets. In case of non observation of instructions, the erring candidates could be disqualified.
