A post of Stenographer (Grade-II) in the office of the Competent Authority and Administrator, SAFEMA / NDPSA, Mumbai, in the Pay Band 2 - ₹ 9300-34800 + Grade Pay ₹ 4200/-, is to be filled up on deputation basis from amongst the eligible and willing officers of Central and State Government. The post belongs to the General Central Service Group 'C' Non-Gazetted.

Eligibility :-

I. Stenographers under the Central or State Government Departments or Organizations.

- (i) holding analogous post; or
- (ii) with 8 years regular service in the grade of Stenographer Grade-III
- (iii) possessing a speed of 100 word per minute in stenography (English)

NOTE:

However, in the absence of candidates with sufficient service, officials with lesser service will be considered.

The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization or Department of the Central Government shall ordinarily not exceed 3 years. The maximum age limit for appointment on deputation shall not exceed 56 years as on the closing date of receipt of application. The Selected candidates will have the option to draw the existing pay with deputation allowance or pay in the new pay scale, if selected to a higher post.



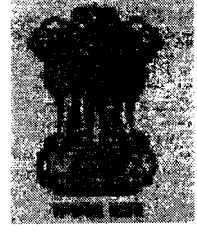

Dear Chief Commissioner,

The rising pendency of Appeals in the Tribunal is a cause of concern. The revenue locked on account of pending litigation has increased substantially and immediate measures are required to ensure that revenue due to the Government is realized by early disposal of cases. Some of the issues pending in appeals are of recurring nature where identical or substantially similar issues of different periods are in dispute before the Tribunal. Some of these issues are of recurring nature while some of the appeals could be covered by decisions of the Supreme Court or High Courts. Therefore, there is a need to classify and bunch appeals so that the same are disposed of, batch wise, saving considerable time of the Tribunal benches.

The President of the Tribunal has informed that the CESTAT Registry and supporting staff are not equipped to identify related appeals for bunching the cases issue-wise or on the basis of covered cases. He has requested for posting six Superintendent level officers from the Department on loan basis at Mumbai and New Delhi benches for a period of six months for identifying the cases and grouping them to ensure speedy disposal of cases. Similarly, three Superintendent level officers may be posted to the benches at Chennai, Bangalore, Kolkata and Ahmadabad for a period of six months as a temporary measure.

You are, therefore, directed to post two Superintendents each from Central Excise, Service Tax and Customs Zones at Delhi and Mumbai Bench who are well conversant with the subject for a period of six months to the Tribunal Registry. Similarly, for Tribunal Benches at Ahmadabad, Bangalore, Chennai and Kolkata, three Superintendents may be posted for a period of six months for this work. A copy of the deputation order may be sent to the office of Chief Commissioner (AR), CESTAT, New Delhi and the same may be endorsed to the Joint Secretary (Judicial Cell) for information. The posting of the Superintendents as mentioned above may be done in coordination / consultation with counterparts in the same city to ensure that the desired numbers of officers are posted for the job.
