Sub:- Preparation of panel for the post of sr. Intelligence Officer on deputation basis in the Directorate General of Export Promotion, Delhi - reg.

It is proposed to draw a panel of suitable and eligible officers to fill up a vacancy of Sr. Intelligence Officers (Group "B") in the office of Directorate General of Export Promotion, New Delhi.

2. This post will be filled up on deputation basis from amongst officers of the similar rank (i.e. Superintendent/Appraiser) working in the formations of customs and Central Excise or officers holding analogous posts in the Directorate General/Directorates under CBEC in the same pay scale. The Deputation Allowance will be paid as per the instructions of the Govt. from time to time.

3. Such officer selected for a posting in the Directorate General of Export Promotion would normally for a period of three years, extendable by another two years by the Director General of Export Promotion.

4. It is requested that this vacancy and communication may kindly be circulated among officers in your jurisdiction and the applications of interested and eligible officers below the age of 56 years may be forwarded to this office on or before 10th March, 2015 with their full bio-data including their History of postings alongwith ACR for the last 5 years, Vigilance Clearance and No Objection Certificate.

5. In case, while working in this Directorate General of Export Promotion the work and conduct of the officer is not found to be satisfactory, the officer can be repatriated to the Parent Commissionerate before completion of the aforesaid deputation period.

Sub: Preparation of panel for appointment of Intelligence Officer in the Directorate General of Central Excise Intelligence, DZU, New Delhi and its Regional Units at Ludhiana, Jaipur and Rohtak in the pay Band-2 of Rs.9300-38400/-+Grade pay of Rs. 4600/-on deputation basis – reg.

The Directorate General of Central Excise Intelligence, Delhi Zonal Unit is in the process of drawing a panel of willing and suitable officers for filling up the vacancies in the grade of Intelligence Officer on deputation basis in its Zonal Unit at Delhi and the Regional Units at Ludhiana, Jaipur and Rohtak.

It is proposed to fill up these vacancies by appointing suitable officers from the grade of Inspector of Customs & Central Excise. The officers who have been granted financial upgradation under the MACP Scheme, are also eligible for the said posts.

The selected officers, while working in the Directorate General in the grade of Intelligence Officer on deputation basis, will be entitled for deputation allowance as admissible. Normally, the deputation is for a period of five years, which is extendable by another two years, subject to the willingness of the officer, his/her performance, concurrence of his parent Commissionerate and approval of the competent authority.

It is requested that the circular may please be brought to the notice of all the formations under your jurisdiction and the applications of willing officers be forwarded to the Addl. Director

General, DGCEI, Delhi Zonal Unit at the above mentioned address. While forwarding the names of the willing officers, the following information may also be sent for evaluation by this Directorate General.

1. Complete bio-data and willingness of the officer alongwith history of previous postings;
2. ACR/APAR gradings for the last 5 years {duly verified and attested by the Addl./Joint Commissioner (P&V)};
3. Vigilance Clearance; and
4. 'No objection' from the Cadre Controlling Authority to relieve the officer in the event of his/her selection.
