## जन सूचना नं. 11/2015 PUBLIC NOTICE NO.11/2015

In pursuance of the Notification No. 16/2015 dated 1<sup>st</sup> April, 2015 (Para 10), I, P. V. R. Reddy, Principal Commissioner, Customs, Kandla hereby permits import and export under Export Promotion Scheme i.e. Export Promotion Capital Goods (EPCG) scheme through Private Jetty of M/s. Sanghi Inds. Ltd. located at Jakhau port, Ta: Abdasa, Dist: Kuchchh, Gujarat subject to fulfillment of conditions/ provisions specified below in addition to conditions/ provisions specified by the Notification No. 16/2015-Customs dated 14.4.2015.

## Additional Conditions:

- 1. Only captive import/ export of goods are allowed through this jetty. No trading activity or goods belonging to another exporter/ importer is permitted.
- 2. Export and Import of goods as specified in Notification No. 13/2006-07/CCP/Jamnagar dated 23.5.2006 are allowed.
- 3. All Shipping Bill and Bill of Entry under EPCG Scheme should be assessed by the Assistant/ Deputy Commissioner, Customs, Bhuj and necessary endorsement should be made accordingly. Necessary registers be maintained at Bhuj Division and EODCs are monitored regularly.
- Shipping Bill / Bill of Entry should be submitted at least 3 days in advance of shipment of cargo/ unloading of cargo (excluding Saturday/Sunday and holidays).
- 5. Importers will produce Release Advice, in respect of import of goods under EPCG, issued by the authorities of port of registration of EPCG licence at the time of such importation.
