

2. The Chairman welcomed the members and informed that no specific issues or agenda points for the meeting have been received from any stakeholder or individual importer/exporter. However, members can offer inputs and raise any issues relating to the matter of clearance of imported and export goods.

3. Members from Plant Quarantine Station, Kandla & Mundra have informed that they are in the process of fully integrating with the newly introduced ICES module and it may take one or two months to

fully cope up with the process, they are still issuing the manual 'Release Order' apart from the System, therefore, they have requested to accept 'Release Order' issued by them manually for the time being also. The Chairman agreed to their request. However, he suggested to take care of the initial difficulties and clearances need to be given online only and to discontinue manual release order as quickly as possible.
