

3	Conditions to be fulfilled by the applications	See Regulation 5 & 6 of CBLR, 2013
4	Syllabus of written Examination	See Regulation 6 (7) of CBLR, 2013
5	Application to be submitted in format	Form A (available in the notification) along with two passport size self-attested photographs (on the front side) & self-attested documents on citizenship, educational qualification & financial requirements as per regulation 5 of CBLR, 2013. Before submitting the application, applicant should ensure the completeness of the application, as no deficiency memo will be issued and incomplete applications shall be rejected. Applications sent by post and if received after the last date shall not be entertained.
6	Where to submit the application	OFFICE OF THE COMMISSIONER OF CUSTOMS, NEW CUSTOM HOUSE, KANDLA, Near Balaji Temple, Kandla - 370210.
7	Information regarding allotted roll number, admit card & examination venue will be intimated to individual applicant. Names of applicants found eligible to appear in examination will be displayed on the notice board and/or website latest by 24.11.2017.	
8	Successful candidates will be called for an oral examination for which separate communication will be sent.	
9	The candidates have the option to answer either in English or in Hindi.	
10	In case declarations and information submitted by the applicant are found to be incorrect, the application shall be rejected or license, (if issued) shall be cancelled.
