**Sub:- Registration with Customs House Agents Association  
By Customs Broker under Regulation 24 of CBLR-2013**

Attention of all the Customs Brokers and other concerned persons is invited to Regulation 24 of Customs Brokers Licensing Regulation, 2013, wherein it has been provided that each Customs Broker shall enroll himself as a member of the Customs House Agents' Association, if any, registered at Customs Station and recognized by the Commissioner of Customs.

2. In this regard, it is to inform that the Customs House Agents' Association having its office at Room No.7, 2<sup>nd</sup> floor, Chamber of Commerce building, Plot No.71, Sector-8, Gandhidham, Kutch -370201 is a recognized association approved by the Commissioner of Customs, Kandla vide Public Notice No.26/2011 dated 30.08.2011.

3. It has been brought to the notice of the undersigned that numbers of Customs Brokers are not registered with the Kandla Customs House Agents' Association as required under Regulation 24 of CBLR-2013.

4. It is therefore, emphasized that all the Customs Brokers may get themselves registered with the Kandla Customs House Agents' Association, if not already done so, and produce the proof thereof immediately to Deputy/Assistant Commissioner (CHA), Customs House, Kandla. Failure to which, action will be initiated under the provisions of Regulation 20 of CBLR 2013 for the contravention of Regulation 18 (b) of CBLR-2013.
