- 2. The Chairman welcomed the members and informed that no specific issues or agenda points for the meeting have been received from any stakeholder or individual importer/exporter.
- 3. The issue of E-Delivery order by the shipping lines was the priority for deliberations. It is observed that importers or their representatives have to visit the counters of the Shipping Lines for payment and collect a paper copy of the Delivery order which involves huge time loss. In order to avoid this, a detailed discussion was held on E-delivery Order. The electronic mode of transactions will

substantially reduce the dwell time in the Customs Clearance process and also reduce transaction costs in the process. It will further be in line of Government's initiative of 'Ease of Doing Business'.

- 4. Further, it was brought to the notice that some shippers like M/s MSC (I) Private Limited has already started accepting e-mode of transactions. During the meeting, a consensus was reached to accept the e-invoicing, e-payment and e-delivery order by all the stakeholders. The Chairman advised all the stake holders to meanwhile examine the above procedures and kindly intimate any difficulties that may be faced in implementing, to the notice of the undersigned in the next CCFC meeting which is fixed on **03.03.2016 (11.30 hrs) at the**Mundra Custom House, Mundra for both the Commissionerates. All the office bearers of various associations are requested to attend that meeting since a final decision is going to be taken on the procedures to be followed.
- 5. It is proposed to be mandatorily implemented w.e.f 01.04.2016.

6. The meeting ended with vote of thanks to the Chair.
