In pursuance of Ministry of Finance (Dept. of Revenue) Notification 82/2017 - Cus (N.T.) dated 24th August 2017 read with Notification No. 86/2017 - Cus (N.T.) dated 14th September 2017, Notification No. 99/2017 - Cus (N.T.) dated 27th October 2017, Notification No. 119/2017 - Cus (N.T.) dated 28th December 2017 and Notification No. 03/2018 - Cus (N.T.) dated 10th January 2018, the Customs related work is shifted to Customs Commissionerates from the GST Commissionerates w.e.f. 15.01.2018.
