**ANNEXURE-I**  
**(Terms and conditions)**

1. Quotation for such work to be submitted with Bid Security of 2% of the bid amount in the form of FD pledged in the name of the Commissioner of Customs, Custom House, Kandla.
2. The vessels can be inspected for the works to be carried out at the location as mentioned above on any working days with prior intimation on Phone No. 02836-271468.
3. Quotation to be submitted for operationalisation of the boat (Engine & Deck).
4. Fitted systems, equipments of vessels and their controls may be inspected to ascertain defects, if any, for consideration of estimation.
5. For Service Routines & Repair works of OBMs of Mercury Mariner 250 HP EFI Engines the agency / firm should have an experience of at least 03 (three) years with sufficient manpower and presently handling similar nature of work.
6. All spares, consumables, paints, oil & lubricants, materials etc, required to carry out repairs shall be supplied by the firms including crane services, transportation etc. if required.
7. After completion of works, sea trials at full powers to be conducted for satisfactory performance of all machineries, equipment and systems fitted on the vessel and payment will be released only after completion of all work. No partial payment will be released for partial work done.
8. Financial Bid of only those firms will be considered who are found eligible in their Technical Bid.
9. The bidder shall arrange necessary Insurance coverage for any persons deployed by him/her. This office shall not entertain any claim arising out of mishap, if any that may take place. In the event of any liability/ claim filing on this office, the same shall be reimbursed/ indemnify by the bidder.
10. Bidder shall be fully responsible for theft, burglary, fire or any mischievous deeds by him/her or his/her staff.
11. The work carried out should be guaranteed for a period of six months from the date of successful trials of the vessel.
12. The firm is required to submit 10% of order value as PBG (Performance Bank Guarantee) i.e. Six months and same will be released post completion of Guarantee period provided no problems arise / problem arisen are rectified during guarantee period, free of cost.
13. The firm is required to complete the repair works and sea trials within 45 days from the date of work order. In case the repairs are not completed within the time frame, liquidated damage of Rs. 5000/- per week till completion of works and sea trials shall be deducted from the payment.
14. Original Mercury parts must be used for replacement of any damaged part.
15. The charge quoted should be inclusive of all taxes & other charges.
16. No escalation of price whatsoever would be allowed during the ongoing work of the contract.
17.
