In exercise of powers conferred upon me, under Section 8 of the Customs Act, 1962 (52 of 1962), I, Sanjay Kumar Agarwal, Commissioner of Customs, Kandla Commissionerate, Kandla hereby cancel/revoke the Notification No. 05/2013 dated 11.10.2013 and approving the place as specified in the schedule of the said notification for import/export and coastal movement of multipurpose cargo (other than liquid and containerized cargo) at Kandla Port (now Deendayal Port) for 15<sup>th</sup> Cargo Berth/Wharf Structure and backup area of 15<sup>th</sup> Cargo Berth to M/s JRE Infra Pvt. Ltd., IOC Offshore Terminals, Opposite Shirav Railway Crossing, New Kandla (Kutch)-370201, under section 8(a) of the said Act with reference to request letter dated 28.09.2018 by Deendayal Port Trust wherein they have informed that they had terminated the Licence Agreement entered into with M/s JRE Infra Pvt. Ltd., for development of Multi-purpose Cargo Berth no.15.
