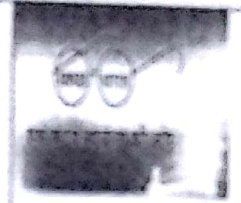

**NOTIFICATION NO. 09/2018**

In exercise of powers conferred upon me, under Section 8 of the Customs Act, 1962 (52 of 1962), I, Sanjay Kumar Agarwal, Commissioner of Customs, Kandla Commissionerate, Kandla hereby cancel/revoke the Notification No. 02/1995-Cus dated 19.10.1995, as amended vide Notification No. 1/2004-Cus dated 23.12.2004 and 01/2005-06 dated 2.2.2006 specified the entire area of Container Freight Station located at Central Warehousing Corporation, Plot/Survey No.227, Village Kidana, Near KASEZ, Adjacent to FCI Godown, N.H.8A, Gandhidham (Kutchh), as "Customs Area" for storage of containers & goods contained therein imported through Kandla Port and Mundra International Container Terminal (MICT), Mundra Port and stuffing of export cargo and de-stuffing of import cargo exported /imported through Kandla Port and MICT-Mundra Port as Gateway /Exit Port.

2. The Custom Area notified under said notification in respect of Central Warehousing Corporation, CFS-Gandhidham, stands de-notified for landing under place for import/export with immediate effect.
