It is hereby informed that 'F' Category CBLR Examination under Regulation 6 of the CBLR,2018 for the year 2019, shall be conducted on 15.03.2019 at designated examination centers across India. There will be 150 questions of 2 marks each and to pass the exam, a candidate will be required to score minimum 180 marks. There will be no negative marking. Those qualifying in said examination will have to appear for oral examination in terms of Regulation 6 of said Regulations.

A link to download the admit card will also be provided therein. Admit cards shall also be sent by email to eligible applicants 15 days in advance before the date of examination. Reference is invited to the Notice dated 27.04.2018 and Corrigendum dated 11.12.2018 inviting applications for the Customs Brokers Examination to be conducted by Directorate General of Performance Management.
