- 3. उक्त अपील यह आदेश भेजने की दिनांक से 60 दिन के भीतर दाखिल की जानी चाहिए।

  Appeal shall be filed within sixty days from the date of communication of this order.
- 4. उक्त अपील के पर न्यायालय शुल्क अधिनियम के तहत 2/- रुपए का टिकट लगा होना चाहिए और इसके साथ निम्नलिखित अवश्य संलग्न किया जाए-

Appeal should be accompanied by a fee of Rs. 2/- under Court Fee Act it must accompanied by -

  While submitting the appeal, the Customs (Appeals) Rules, 1982 and other provisions of the Customs Act, 1962 should be adhered to in all respects.

  An appeal against this order shall lie before the Appellate Authority on payment of 7.5% of the duty demanded wise duty or duty and penalty are in dispute, or penalty wise penalty alone is in dispute.

Subject:- Revocation of suspension of Customs Broker license of M/s Bright Shiptrans
Pvt. Ltd, Gandhidham.

The facts in brief of the matter are that M/s Bright Shiptrans Pvt. Ltd., 244, Sector 1A, Gandhidham, Kutch District, Gujarat (formerly; Plot no. 333, Sector1-A, Opp: BMCB Park gate, Oslo Circle, Gandhidham), is holding CB Licence No. KDL/CHA/R/06/2011 (PAN- AACCB5107E), issued by Custom House, Kandla, valid up to 09/02/2021, in terms of the Customs House Agents Licensing Regulations, 2004.

- 2.1 The Deputy Commissioner (CBS), Custom House Mundra vide letter F. No. S/07-07/CBS/2017-18 dated 19.04.2017 has forwarded Order F. No. S/07-07/CBS/Mundra/2017-18 dated 18.04.2017 issued under the provisions of Regulation 23 of CBLR,2013 by the Principal Commissioner Custom House, Mundra, under which the Customs Broker M/s. Bright Shiptrans Pvt. Ltd. was prohibited from transacting business in the jurisdiction of Customs Commissionerate, Mundra
- 2.2 The Principal Commissioner of Customs, Kandla in exercise of powers conferred under Regulation 19 of CBLR, 2013, ordered to suspend the CB Licence No. KDL/CHA/R/06/2011, (PAN No. AACCB5107E) of M/s. Bright Shiptrans Pvt. Ltd., vide Order F. No. S/7-58/CHA/2009 dated 25.04.2017 with immediate effect. Further, in exercise of powers conferred under Regulation 19 of the CBLR, 2013, read with Regulation 11 of CBLR, 2013, the Principal Commissioner of Customs, Customs House Kandla confirmed the continued suspension vide order F. No. S/7-58/CHA/2009 dated 11.05.2017.
- 3. The Customs Broker has filed appeal before the CESTAT, WZB, Ahmedabad against the Suspension Order dated 11.05.2017. The Tribunal, Ahmedabad vide Order No. A/11225-11226/2018 dated 10.04.2018 has set aside the impugned Order and allowed the appeal filed by the CB for revoking the suspension order dated 11.05.2017.
- 3.1 The department has filed appeal (Tax Appeal No. 5299/2019) before the Hon'ble High Court of Gujarat along with Civil Application {CA/01/2019(stay)}, which is pending before the Hon'ble High Court of Gujarat.
- 4. The Additional Commissioner (CBS), Custom House Mundra vide letter F. No. S/07-07/CBS/Mundra/2017-18 dated 31.10.2018 has forwarded a final report in the matter, thereof, Show Cause Notice No. S/7-58/CHA/2009 dated 20.11.2018 was issued by the Commissioner of Customs, Kandla under Regulation 17 of Customs Brokers Licensing Regulations,2018 for the revocation of CB license of M/s Bright Shiptrans Pvt. Ltd, Gandhidham.
- 4.1 The CB M/s Bright Shiptrans Pvt. Ltd have filed writ petition Special Civil Application (SCA) No. 20446/2018 before the Hon'ble High Court of Gujarat against the Show Cause Notice No. S/7-58/CHA/2009 dated 20.11.2018. The Hon'ble Court vide Order dated 24.12.2018 has granted stay on the impugned

- SCN. Thereafter, in compliance of Hon'ble Court Order Department has not proceeded further in the matter of SCN dated 20.11.2018.
  - 5. Further, the Hon'ble High Court of Gujarat vide Oral order dated 29.04.2019 directed the department to forthwith permit the petitioner (M/s Bright Shiptrans Pvt. Ltd) to work as Custom House Agent till further orders.

## ORDER

Accordingly, I order to revoke the suspension of the Customs Broker License No. KDL/CHA/R/06/2011 (PAN: AACCB5107E) issued to M/s Bright Shiptrans Pvt. Ltd., 244, Sector 1A, Gandhidham, Kutch District, Gujarat-370201 (formerly; Plot no. 333, Sector1-A, Opp: BMCB Park gate, Oslo Circle, Gandhidham) subject to outcome of Tax Appeal No. 5299/2019 and Civil Application - CA/01/2019 (stay) filed by the department before the Hon'ble High Court of Gujarat against the CESTAT Order No. A/11225-11226/2018 dated 10.04.2018.
