**MINUTES OF THE MEETING OF CCFC HELD ON 23.05.2019**



2. The Chairman welcomed the members and informed that no specific issues or agenda points for the meeting have been received from any members. However, members can offer inputs and raise any issue relating to the matter of clearance of import and export goods but there was no suggestion from the members.

Shri Gaurav Dutt, Sr, Manager, KICT has raised the issue, that during gate in of e-sealed export containers arrived from ICD by road, sometimes the vehicle number is different from the vehicle number shown in the system of Preventive officer, posted at Gates. Due to this the containers are kept on hold by Preventive Officers and they insisted for permission from Superintendent, Dock Preventive and this result to delay in “gate in” of the said containers. The Chairman observed that the matter needs to be examined and directed Assistant Commissioner (DP) to examine the issue of transshipment of e-sealed containers arrived from ICD to Kandla port for export purpose.
