SUBJECT: Notification of FSSAI's Authorised Officer for Deen Dayal Port at Kandla under Section 47 (5) of FSS Act, 2006-Reg.

The Food Safety and Standards Authority of India has been established under the provisions of Food Safety and Standards Act, 2006 as statutory body for laying down science based standard for articles of food and to regulate manufacture, storage, distribution, sale and import of goods so as to ensure availability of safe and wholesome food for human consumption.
