

Advocates who have been in practice as an advocate for not less than 10 years & also qualify in terms of Section 24(8) of the Criminal Procedure Code, 1973 may submit their application along with the Bio-Data in Proforma "A" to the Legal Section, Office of the Commissioner of Customs, Custom House, Kandla, Near Balaji Temple, New Kandla - 370210 by **20.11.2020**. 2. The first engagement of an SPP shall normally be for a period of 18 months: Such engagement will be renewable on receipt of recommendation of the concerned Chief Commissioner alongwith the annual performance appraisal completion of first 12 months of the engagement.
